- Cefn Saeson school Construction traffic travelling through Pontrhydyfen (prohibited zone for HGV).
- Fly tipping at Cefn Saeson
- Bus shelters have been cleaned.
- Cllr Hurley will circulate Pen y Cymoedd grant awards to date.
  - Cllr Hurley will provide PCC with details on the forthcoming meeting at Blaengwynfi regarding applications for Pen y Cymoedd grants.
  - Cllr Hurley has agreed to send Community Council an application form to access member fund grants.
  - Cllr Hurley will send ward demographics to Mr John Rawlinson to assist grant application.
  - Cllr Hurley drew attention to current consultation on Boundary Commission proposals relating to NPTCBC Pelenna ward.

#### a. CMO Report

#### b. Member comments/requests

- NPTCBC Road sweepers have been in use in the community.
- Pot holes have been filled by NPTCBC in Tonmawr.
- Quotations should be obtained for Marine ply back board replacement incorporating safety bolts on play equipment at Johns Terrace playground.

#### 12. 2019/217 Update on Christmas events programme

A set of keys for the outside sockets at Tonmawr and Pontrhydyfen must be obtained for safe keeping by the Community Council.

- Additional memorial stars have been requested by residents. Cllrs Diane Evans and Janice Evans will enquire whether these additional requests may be satisfied by the supplier.

- Arrangements at the Santa parade on Friday 6<sup>th</sup> December were summarised: Cllr Patrick Davis will drive ahead of Santa to assist Road safety; the police will follow:
