4 2022/185 Matters arising

EOI form in respect of a Pen y Cymoedd community grant for John's Terrace playground has been completed and will be submitted tomorrow. If the PYC panel is satisfied with the EOI on 23rd January they may invite submission of a full application for consideration on 10th April. The grant application is for £91,570. Additional grant assistance will also be needed from Neath Port Talbot CBC of £14,000.

The draft lease for Miles Field, Tonmawr, has been received and sent to all Members of Council for review. Amendments

have been agreed with NPTCBC on 'Boundary walls' supported by all Members of Council that the lease should be accepted with agreed amendments on boundary walls and fences. Clarification has been obtained on an insurance cover issue and the use of information boards

Proposed by Cllr Morgan Thomas, seconded by Cllr Carl James, supported by all Council members that the agreed lease be accepted, and when completed will be signed by the Chair and Vice Chair, with substitutes if either member is unavailable. A pothole in the road between the Mission bend and the Slip was reported, and this was noted by County Borough members present to be passed to the relevant department.

Cllr Lisa Hawkes, Chair of Council, reported that she has donated the whole of the Chair allowance equally between the junior sections of Tonmawr and Pontrhydyfen Rugby clubs. Cllr Jason Jarvis informed the meeting of concern over two boulders which have been placed in the lay-by on the road above Penrhys farm. It is understood that the boulders have been placed there by the farm owners
