10. 2020/011 To discuss a response to the Boundary Commission draft proposal in respect of changes relating to the County Borough ward boundary involving Pelenna community.

The Boundary commission has determined that the existing Pelenna ward should amalgamate with Bryn, Oakwood and Cwmavon.

Members considered it more appropriate if Oakwood and Cwm evan bach communities were linked to the existing Pelenna ward.

In the event that Pelenna is linked to Bryn, Oakwood and Cwmavon members felt that there would be a dilution of Services and that current protection for our Rural community will be lost. Pelenna community has already lost both of its well performing primary schools and it is inevitable that other services will also be lost. Pelenna residents believe that good representation will be lost and that a further decline will be felt. Three Councillors only, covering Bryn, Oakwood, Cwmavon and Pelenna will not provide adequate community representation and the statistics indicate that the Councillor/ elector ratio will be too high resulting in under representation. The above Community Council response will be sent to the Boundary Commission prior to the closing date of the current consultation period.

11. 2020/012 To receive an update on the current vacancy in the Tonmawr ward of Pelenna Community Council. It appears that there has been no call from the Community for an election to fill the vacancy. It was therefore decided to declare that the Council intends to fill the vacancy by cooption and an advertisement will be published to this effect. One expression of interest has already been received.
